Privacy Policy

Spiegel & Grau, LLC ("S&G," "we" or "us") respects your privacy. We created this privacy policy ("Privacy Policy") for our website accessible at www.spiegelandgrau.com (the "Website") to demonstrate our firm commitment to your privacy and to help you understand how your information is collected and used. By using or accessing the Website, you agree to be bound by our Privacy Policy. If you do not agree to this Privacy Policy, you may not access or otherwise use the Website.

Personally Identifiable Information That We Collect

S&G only collects personally identifiable information about you that you voluntarily submit to us. We may collect this information in a variety of ways, including without limitation when you subscribe to our newsletter. How We Use Your Information

- We may disclose your personally identifiable information to protect the safety, rights, or property of the public, any person, or S&G; to investigate, prevent, or otherwise address suspected fraud, harassment or other violations of any law, rule or regulation or the Terms of Use for the Website; to detect, prevent or otherwise address security or technical issues; or as we believe is required by law, regulation, or legal process.
- We do not sell or rent your personally identifiable information to third parties; provided, however, we may engage in a merger, acquisition, disposition, change of control, bankruptcy, dissolution, reorganization, or similar transaction or proceeding that involves the transfer of your information.

We may share non-personally identifiable information or generic aggregated demographic information with our partners or other third parties for any purpose.

Security
